Dave and Councillor Putt have been busy working at the Community Rooms, the wall has been taken down, the carpet has been taken up, the painting has nearly been finished in the large room.

1609/07 **A REPORT FROM CORNWALL COUNCILLOR ROY TAYLOR**

I have attended various transport meetings including Transportation PAC briefing on parking.

I also and examined Par Consols mining records at and around the Mount that in turn contributed to the defeat of the Wain Homes Mountside development plans at the subsequent Strategic Planning meeting by 13 votes to 3 with 1 abstention.

I attended and spoke at Cabinet getting the Par Lane irresponsible parking and lack of yellow line situation aired on the webcast.

I attended a Communities PAC and another of PAC chairs with the Cabinet where I aired the lack of local members' highway schemes yet again.

I participated in Devolution and Governance briefings, a meeting of Cornwall Community Flood Forum and a meeting on the St Blazey Neighbourhood Plan and held a councillors advice surgery.

I have attended a Hands Together meeting and the latter stages of the Landreath Street Party, a Fourways management meeting, a Burrows Board, a Roundhouse Board and a PBBL meeting as well as the AGM of Grow St Blazey.

New signage is now in place on Cornhill Road. "Unsuitable for HGV s" at the top and two visual signs indicating the same at the bottom. Although the signs are back in place diverting traffic away from Prideaux Road I have been assured that signage has been changed at Dobwalls so that Eden traffic is directed down the A38 rather than A390. Feedback I have had indicates that this time the impact on St Blazey is a lot less.

A brief burst of heavy rain last Saturday evening forced up manhole covers allowing sewage onto the street again in the lower part of Par Lane. The road at Brook's Corner had standing "water" for a while. Thankfully, no properties were flooded.

Bramble and other weed growth continues to be an issue across my division. Ocean have cleared some weed growth on Par Lane and I have been out cutting brambles that homeowners don't.

The road at Kilhallon is still closed and I am still assured will be reopened before the given date. Originally 20th May to 27th July 2016 now extended until 14th October 2016(24 hours, weekends included).

1609/08 **A REPORT FROM CORNWALL COUNCILLOR DOUG SCRAFTON**

Councillor Scrafton is unwell and so there is no report.

1609/09 **THE FUTURE GRASS CUTTING ARRANGEMENTS FOR DOUBLETREES COURT**

Two residents from Doubletrees Court asked if we would continue with the grass cutting of their Green for another year. Councillor R Taylor proposed that we renew the arrangement for the year at the same cost, Councillor Wheeler seconded the proposal, all the Councillors agreed and so it was RESOLVED.

1609/10 **ST BLAZEY COMMUNITY ROOMS**

The police removed the telephone lines by 5th September but unfortunately did not removed the alarms which hindered progress. Councillor Putt arranged for All Connections Electrical to move the heaters etc so allow work to begin. Councillor Putt

and the Warden have removed the wall that will make the main room larger and made good and have nearly finished painting the main room.

A Carpenter has removed the old kitchen cupboards and the Clerk has received a quote for £485.37 for new. All the Councillors agreed with quote and so it was agreed to proceed.

A plumber has removed the under counter water heater which was leaking and the Clerk has been quoted £199.97 + labour to have this replace. The Council agreed that this should go ahead.

The Clerk is waiting for a quote from a fire alarm company and was told to act as necessary.

1609/11 **IMPLICATIONS OF LOCALISM AND CORNWALL COUNCIL CUTS**

The Clerk has been informed that the transfer of King Edward Gardens from Cornwall Council to St Blaise Town Council has gone through the Strategic Devolution Group. This is a group of officers from Localism, Environmental, Legal, property etc. who look at the Initial Proposal form submitted and decide whether to take the request to the next stage. KEG has been through this process and given the go ahead.

The next step is for a Director's report which is being written for final approval. This report details things such as the Cory costs (waste), the Forestry Officer's report, any comments property and the rest of the Environment team may have, legal also have an input for a Director to agree.

CC are still working through the 16/17 programme – which includes KEG – and are hopeful to get it through by November/December.

The St Blazey, Fowey and Lostwithiel Community Network Panel have awarded us £5,000 from the Local Devolution Fund for legal costs and maintenance work.

1609/12 **TO RE-ALLOCATE FUNDS FROM PAR & TYWARDREATH COUNCIL TO THE RUNNING TRACK GROUP FOR THE MAINTENANCE OF THE SK8 SKATE PARK WHEN COMPLETD**

It is the intention is for the newly formed Par Running Track Group to take over the track and surrounding facilities from April 2017. This has been agreed by all concerned and will include the skateboard park project. In the circumstances, it seems inappropriate for the Town Council to commit itself to help fund maintenance of the skateboard park for an indefinite period as agreed at the meeting on 29th August 2013, as this ought to become the responsibility of the running track group.

Councillor Seel proposed that the agreed grant be veered to the Par Running Track group for a period of two years once built, Councillor Putt seconded the proposal, all the Councillors agreed and so it was RESOLVED.

1609/13 **PROPOSED CLOSURE OF TELEPHONE BOXES IN ST BLAZEY**

BT have written to CC as part of the formal consultation process regarding the current programme of intended public payphone removals. BT advise that, overall use of payphones has declined by over 90 per cent in the last decade and the need to provide payphones for use in emergency situations is diminishing all the time, with at least 98 per cent of the UK having either 3G or 4G coverage.

BT are proposing to close the telephone box at Landreath Place which was used 64 times in the past year, Station Road used 449 times and Middleway 9 times in the same period.

Councillor R Taylor proposed that we object to the closure of Station Road telephone box, give our concerns regarding Landreath Place and agree to the removal of Middleway, Councillor Seel seconded the proposal, all the Councillor agreed and so it was RESOLVED.

1609/14 **PROJECT LIST**

Neighbourhood Planning – The results of the Local Plan have said that if the Par Docks Development does not go ahead within a certain amount of time, the 300 homes designated for the site will be spread across our Community Network Area.
